Wherupon all and Singular the premises by the Court here being seen heard and fully understood It is Considered by the Court here that the aforesaid Martin Henry pay to his Lordship the Lord Proprietary for his fine by the Court here upon him imposed for and by occasion of the trespass and assault aforesaid whereof in form aforesaid he is found two hundred pounds of tobacco and that the said Martin Henry be taken to satisfy his said Lordship of the fine aforesaid - Likewise the said Martin Henry is committed under custody of the Just of Somerset County thereto remaine until he satisfy unto the severall Officers <sup>their</sup> fees due by occasion of the premises &c. wherupon the said Just. to witt Joshua Caldwell Gent present here in Court took charge of the said Martin Henry accordingly &c.

Thomas Lord - } for the body of Somerset County upon their oaths do present that Thomas Lord -  
late of Somerset County Labourer the twentieth day of June in the year of  
our Lord one thousand Seven hundred and thirty two with force and armes &c. in  
the County of Somerset aforesaid in and upon a certain Thomas Dunkan in the peace of  
God and the aforesaid Lord Proprietary then and there being an assault made and him  
the said Thomas Dunkan then and there beat Wounded and Evil Intreated so that  
of his Life it was Greatly Despaired and other Enormities to him then and there  
aforesaid to the great Damage of him the said Thomas Dunkan and against the  
peace of the Right Honble the Lord Proprietary &c. - J. Bluet & Don Prop. -

Thereupon Command was given to the Sher. of Somerset County that he should take  
the said Thomas Lord if he will to answer &c. And afterward in <sup>the</sup> same Court -  
before his Lordships Justices at Dividing Creek to witt the twentieth day of June  
Ann Dom. one thousand Seven hundred and thirty two came the aforesaid Tho:  
Lord in his proper person ~~Answered~~ and Defends the force and Injury when &c.  
and says that he cannot deny but that he is guilty of the trespass and assault aforesaid  
in the Indictment aforesaid Specified above upon him Imposed in manner -  
and formed as by the Indictment aforesaid above against him Supposed where -  
upon all and Singular the Promise by the Court <sup>being</sup> fully understood -

It is Considered by the Court here that the aforesaid Thomas Lord pay to his Lordship -  
the Lord Proprietary for his fine by <sup>the</sup> Court here upon him imposed for and by occasion  
of the trespass and assault aforesaid whereof in form aforesaid he is found fifty pounds of tobacco  
and that the said Thomas Lord be taken to satisfy his said Lordship of the fine aforesaid Likewise the said  
Thomas Lord is committed by the Court here under the <sup>Custody of the</sup> Just. of Somerset County thereto remaine until he satisfy  
unto the severall Officers fees due by occasion of the premises &c. wherupon the said Just.  
to witt Jos. Caldwell Gent present here in Court took charge of the said Tho Lord accordingly &c.
