Wherupon the aforesaid George Bailey Garnishee of the aforesaid John Persons altho: solemnly called Come not nor shows Cause why he but makes default. -

Wherupon the aforesaid Levin Gale present herein Court in his proper person prays that upon giving Security according to act of assembly in such case made and provided the aforesaid Sum of Six pounds Curr: money so as aforesaid attached may be condemned in the hands of the aforesaid George Bailey as of the Rights and Credits of the aforesaid John Persons to ward Satisfying unto him as well the Sum of five pounds Curr: money mentioned in the attachment aforesaid, as also all Costs arising by means of the same attachment he which is to him granted. he -

Thereupon a certain William Stoughton of Somerset County Gent: present herein Court in his proper person undertakes for the said Levin Gale that in case the said John Persons shall at any time within a year and a day appear and make all or any part of the said Levin Gale Claim against him, to be Satisfied, or otherwise due before the Laying of the attachment aforesaid that then the said Levin Gale shall make restitution unto the said John Persons of all, or such part thereof as shall be made appear to be undue or that the said William Stoughton will do the same for him he

Therefore it is considered by the Justices here that the aforesaid Sum of Six pounds Curr: money so as aforesaid attached may be condemned in the hands of the said George Bailey as of the Rights and Credits of the said John Persons to ward Satisfying unto the said Levin Gale the aforesaid Sum of five pounds mentioned in the attachment aforesaid as also all Costs arising thereon, and that the aforesaid Levin Gale have Warrant of his Execution against the said Geo. Bailey according to act of assembly he -
