In Pursuance to an act of Assembly of this Province now in force and in Obediance to the aforesaid Warrant the following Attachment was issued against goods and Chattells Rights or Credits of the aforesaid Theophilus Dennis the tenor whereof followeth in these words Viz: - Somerset Jr: Charles absolute Lord and Proprietary of the Provinces of Maryland and Avalon Lord Baron of Baltimore &c To the Sher: of Somerset County Greeting we Comand you that you Attach any the goods Chattells Rights or Credits of Theophilus Dennis - Sale of Somerset County Planter if they shall be found in your bailiwick to the Value of three hundred pounds of Tobacco and when you have the Same Attached or any part thereof the Same in your Custody Safe keep so that you have the Same before our Justice of our County Court of Somerset ~~at~~ to be held at Dividing Creek the third Tuesday of June Next then and there to be condemned according to act of Assembly to and for the Use of A certain - Saul Townsend Unless the Said Theophilus Dennis by himself or his Attorney Shall appear and answer unto the Said Saul Townsend in a plea of - trespass upon the Case &c according to Law and that by good and Lawfull men of your bailiwick you make known unto the Person or Persons in whose hands you make the Same Attachment that he she or they be and Appear before - the Justice of our County Court to be held as aforesaid to shew Cause if any he she or they have why the Same goods Chattells Rights or Credits so Attached in his her or their hands ought not to be condemned and Execution there of had and made according to act of Assembly in Such Case made and provided if to him her or them it shall seem meet and how you shall Execute this Writt that you make known unto our said Justice at the day and place aforesaid and have you then and there this Writt Witness Sam: Hopkins Genl Chief Justice of our said Court the twenty fifth day of March in the seven tenth Year of our Dominion & Ann^d Dom^o one thousand Seven hundred and thirty two -
At which said third Tuesday of June to witt the twentieth Day of the same month Ann^d Dom^o one thousand Seven hundred and thirty two being the day of the returne of the Said Writt Cometh the aforesaid Saul Townsend by Francis Allen -
