

Baltimore: To the Sher. of Somerset County Greeting we Command you that you -
 Attach any the goods Chattells ^{rights & credits} of Robert Harper Late of Somerset County Joyner
 if they shall be found in your bailiwick to the Value of three pounds Nine Shillings
 and three pence half penny Currant money and five hundred pounds of Tobacco and
 when you have the Same Attached or any part thereof the Same in your Custody
 Safe keep so that you have the Same before our Justices of our County Court of Somers
 to be held at Dividing Creek the third Tuesday of June Next then and there to be -
 Condemned according to act of Assembly to and for the Use of a Certain Thomas -
 Latham unless the Said Robert Harper by himself or his Attorney shall appear
 and Answer unto the Said Thomas Latham in Appla of trespass upon the Case
 according to Law and that by good and Lawfull men of your bailiwick you make
 known unto the Person or persons in Whose hands you make the Same Attach-
 ment that he she or they be and appear before our Justices of our County Court to be
 held as aforesaid to shew Cause if any he she or they have Why the Same goods -
 Chattells Rights or Credits so Attached in his her or their hands ought not to be
 Condemned and Execution thereof had and made according to the act of Assembly
 in Such Case made and provided if to him her or them it shall seem meet and
 how you shall Execute this writt that you make known unto our said Justices
 at the day and place aforesaid and you then and there this Will Witness Samuel -
 Hopkins Gent Chief Justice of our said Court the twenty fifth day of March -
 In the Seventeenth Year of our Dominion V: Ann Dom one thousand Seven
 hundred and thirty two. All which said third Tuesday of June to witt the twenty -
 fifth day of the Same Month Ann Dom one thousand Seven hundred and thirty
 two being the day of the returne of the said Will Cometh the aforesaid Thomas Latham
 by Francis Allen his Attorney and the Sher. of Somerset County to whom the
 foregoing writt was Directed ^{Likewise} Comes and makes returne thereof to the Court here
 Endorsed Viz: By Vertue of the within Writt to me Directed to the Justices
 within Mentioned I Certifie that upon 15th day may one thousand Seven
 hundred and thirty two I Attached of the goods and Chattells of the within -
 Named Robert Harper in the hands of John Purnell Junr: and Edmond Gapper
 the Sum of three pounds Nine Shillings and three pence half penny Currant
 money and five hundred pounds of Tobacco and I further Satisfie that by Ld:
 Townson and Nathaniel Gapper and Thomas Latham honest and Lawfull
 men V: I made known to the Said John Purnell and Edmond Gapper that they
 be and appear at the time and place within Contained to shew: as by the
 within precept I am Comanded so answer -
