Att which said next Court to witt the twenty first day of March and Dowd One thousand Seven hundred & thirty One came againe as well the aforesaid Thomas Fletcher as the aforesaid John Beards by their attorney aforesaid and whereupon the same John prays further Leave thereof to Impate here until the next Court and he hath it and the same day is given to the aforesaid Thomas Here also be -

Att which said next Court to witt the twentieth day of June and Dowd One thousand Seven hundred and thirty two came againe as well the aforesaid Thomas Fletcher as the aforesaid John Beards by their attorney aforesaid and the same John as before de foud the force and Injury when he and faith that he is in no sort Gilty of the premises above against him declared alleged and thereof he puts himself upon the Country - - and the plea in like manner -

Thereupon Command is given to the Just. of Somerset County that immediately he cause to come here twelve by whom he who will be to recognize he because as well he and afterwards in in the same Court came the said Just. to witt Joshua Caldwell Gent. and makes return that he hath here ready twelve by his said precept he was commanded, and afterwards to witt the same day of Year Last mentioned came as well the aforesaid plea as the same deft by their attorney afo and the Jurors of that Justice Impannelled being called came to witt James Mynnie, Cannon Wright, Robert Mitchell, John Webb Richard Knight, Edward Maglamory Edward Bearhams William Gledburn Thomas Deal, Michael Holland Joshua Merritt and Lewis Disharoon who to say the truth in the premises being elected byed and sworn upon their Oath did say that the aforesaid John Beards is guilty of the premises in manner and form as the aforesaid Thomas Fletcher by his declaration aforesaid against him complained and afeared the damage of the same Thomas by occasion of the premises beyond his Costs and Charges by him about his Suit in that part appered to five hundred and seventy one pounds of Tobacco and for those Costs and Charges to one pound of Tobacco

Therefore it is foundred that the aforesaid Thomas Fletcher Recover against the aforesaid John Beards his damages aforesaid by the Just aforesaid in form aforesaid afeared as also six hundred and eighty seven - - - pounds of Tobacco for his Costs and Charges aforesaid to the same Thomas by the Court here of his afeared of Justice adjudged which containd damage in the whole do amount to -  
687 Twelve hundred and fifty Nine - - pounds of Tobacco and the aforesaid John in money he - and - whereupon the aforesaid Thomas Fletcher freely had in Court releaseth to the aforesaid John Beards one hundred pounds of Tobacco percell of the damages aforesaid, Therefore the same John of the same one hundred pound of Tobacco be therof quiet be -
