Error Excepted of Betty Gale

AND the said Finch Jones being called appears and sheweth that the said Finch Jones at the prayer of the
Def^t: attorney is adjudged to give special bail to the action afo sheweth that the said Finch Jones at the prayer of the
plaintiff present herein Court undertakes for the said Finch Jones that if in Case the said Betty Gale shall Recover Judgment
in the plea afo against the afo Finch Jones or that the said Finch should be known Court that he the said Finch shall
pay the Condemnation of the Court or tender his body to the Custody of the Sher^{iff}: of Somerset County in Satisfaction thereof
or that he or said Robert Harris will do it for him &c

Whereupon the said Finch Jones in his own proper person comes and defends the fact and injury whereof
and says that he cannot answer the action afo of the afo Betty nor can he say but that he did assume upon himselfe
in manner and form as the afo Betty above against him hath complained, and as to the damage of the same Betty by her by
occasion of the premises in that part sustained the same Finch says and Confesses that the afo Betty hath sustained damage
by occasion of the premises afo further then her Costs and Charges by her about her suit in that part afo to two pounds
thirteen shillings and nine pence current money and not more, and because the afo Betty deny's not this but the same
allegation Confesses to be true per my Judgment, and those damages above Confessed together with her Costs and Charges afo to her
adjudged &c Therefore by Consent of the parties afo it is Considered that the afo said Betty Gale Recover against the afo
said Finch Jones her damages afo to the afo said two pounds thirteen shillings and nine pence current money by the same
Finch in form afo Confessed as also Two hundred and forty two pounds of obano for her Costs and Charges
