John Magan } the said John Magan Late of Somerset County Scholmaster if he should
be found in his Bailly wife and him should take care so that he might have his body before
the Justices of his Lordships County Court of Somerset to be hold at Dwidrig Creek the third
Wednesday of June then next to satisfy unto Nathaniel Brittingham of five pounds seven shillings
and four pence current money and two hundred and seventy four pounds of t^{ob} which to the
said Nathaniel in the same Court before the Justices then at Dwidrig Creek were adjudged for
his damages which he had by Quasi of a certain promise and assumption to the same Nat. by
the aforesaid John made and not performed whereof he is Com^{pl}ant &c.

All which said third Wednesday of June to wit the twentieth day of the same month One thousand
seven hundred and thirty two came the Just^{ices} of Somerset County, and the afo^{re} Nat Brittingham
and said Just^{ices} made to him of the said writ then directed to him in these words following.
