Whereupon the said Aristobulus Christopher present here in Court in his proper person, at the prayer of the aforesaid John Stewart by his attorney is adjudged to give Special Bail to the action aforesaid throughon Heber Whittingham of Somerset County Yeoman present here in Court affirmed upon himself and undertook for the said Aristobulus Christopher that if in fact the said John Stewart should recover Judgment in the plea aforesaid against the said Aristobulus or that the said Aristobulus should be here in Court that then he the said Aristobulus should pay the condemnation of the Court throughon or render his body to the custody of the Shd. of Somerset County in such fashion thereof or that he the said Heber Whittingham will do the same for him —

And the said Aristobulus Christopher by Robert Denekins Henry his attorney comes and defends the force and duty upon the said Heber Whittingham that he cannot gain say the action the action aforesaid of the aforesaid John, nor but that he the said Aristobulus did affirm upon himself in manner and form as the aforesaid John above against him complained and as to the damage of the said John by him by Quascon of the premises in that part sustained, the said Aristobulus saith and confesseth that the aforesaid John has sustained damage by Quascon of the premises beyond his costs and charges in that part appraised to Seventeen pounds Seventeen shillings and four pence current money and not more and because the aforesaid John denies not this but the same allegation confesseth to be true prays Judgment and those damages above confessed together with his costs and charges aforesaid to him adjudged to be —

Therefore by consent of the parties aforesaid it is considered that the aforesaid John Stewart Recover against the aforesaid Aristobulus Christopher his damages aforesaid to the aforesaid Seventeen pounds Seventeen shillings and four pence current money by the said Aristobulus in form aforesaid confessed as also four hundred and Seventy — — — pounds of tobacco for his costs & charges aforesaid to the said John at his request by the Court now here and consent of the parties aforesaid adjudged which certain damages in the whole do amounts to Seventeen pounds Seventeen shillings and four pence current money and four hundred & Seventy — — — pounds of tobacco and the aforesaid debt in money &c
