 upon the Said John prayed the further Leave thereof to Imparle here untill  
 the Next Court and he hath it and the Same Day is given to the afo<sup>r</sup> William  
 here also &c. — Att which Said Next Court to wit the twenty first  
 Day of March ann<sup>d</sup> Dom<sup>o</sup> one thousand Seven hundred and thirty one came  
 again as well the afo<sup>r</sup> W<sup>m</sup> Gasitt as the afo<sup>r</sup> John Holland by there Attorneys
