James Tattman .. bound to Edward Wooten ..

James Tattman (son of John Tattman late of Somerset County decd) is bound by & Court of his own Consent unto Edward Wooten of the same County Shoemaker until he arrives to the age of twenty One years, he being seventeen years of age Last May, the said James Tattman to serve his said Master Edward Wooten the full term aforesaid, during which term the said James Tattman his said Master well and faithfully shall serve his Secrets Keys, his Commandments Lawfully and honestly by every where willingly shall do, and in all things as a good and faithful servant, shall demean himself towards his said Master and all his during the term aforesaid

In consideration of which service the said Edward Wooten present before Court, Covenanteth with the Justices of the same Court, & Court Judicially sitting on behalfe of the said James Tattman that he & said Edward Wooten during the term aforesaid, will Learn his said apprentice the trades of a Tanner & Shoemaker and at the expiration of his servitude give him as many tools as may be sufficient to make a pair of shoes, and also of three years old, and anew Suit of Coats over and above his common wearing Coats, and Likewise provide for his said apprentice meat drink washing Lodging and Coats, and all other necessarys sufficient for such an apprentice to have and wear during the term aforesaid

Whereupon it is ordered by the Court here, that the said Edward Wooten give security for to comply with the Covenants aforesaid

For upon the said Edward Wooten with Joshua Caldwell of Somerset County Gent his Security both present before Court in their proper persons acknowledged themselves to owe and stand Justly Indebted unto the said James Tattman in the sum of twenty pounds Sterling of their bodys goods and Chattels Lands and tenements severally to be made and Lawed to the use of the said James Tattman his heirs and assigns .. If it happen that the aforesaid Edward Wooten do not during the term aforesaid Learn his said apprentice the trades of a Tanner and Shoemaker, and at the expiration of his servitude do not give him as many tools as may be sufficient to make a pair of shoes, and also of three years old, and anew Suit of Coats over and above his common wearing Coats, and do not Likewise provide for his said apprentice meat drink washing Lodging and Coats, and all other necessarys sufficient for such an apprentice to have and wear during the term aforesaid
