Be it Remembered that on the twenty third day of November
James Dowd: one thousand seven hundred and thirty two came into Court before the worshipful
Robert King Esq. and his associates ^{Justices} of the same, Thomas Bluet Gent: who prosecutes for the Lord
Proprietary and gives this Court to understand and be informed that Betty Game late of the said County
Spencer the first day of September in the Year of our Lord one thousand seven hundred and thirty two in
the County aforesaid and within the Jurisdiction of this Court did Commit Fornication with a certain person unknown
and him the said person on the body of the said Betty Game a bastard Child did begett to the high Displea-
sure of Almighty and to the Curious Example of all others in such Case Offending and against the form of
the act of Assembly in such Case made and provided whereof the said Thomas Bluet prays Advice
of the Court in the premises &c.

Thereupon Command was given to the Sher. of Somerset County that he should take the said Betty Game
if he to answer &c. and afterwards in the same Court herewith the twenty third day of November and did one
thousand seven hundred and thirty two come the said Betty Game in her proper person and had clearing of the
Information aforesaid, and being justly demanded how she would acquit herself of the premises aforesaid
above upon her imposed, says that of the premises aforesaid as aforesaid upon her imposed she is guilty
thereof, and the premises in the Information aforesaid Et profely Confesseth &c.

Whereupon all and Singular the premises by the Court has been heard and fully understood
It is Considered by the Court here that the aforesaid Betty Game punished at the Barber's shop with
whip and Lashes well laid on her bare back with a Rod and while the blood appears &c. and thereupon
as to the Corporal punishment aforesaid Command is given to the Sher. of Somerset County
that he do thereof Immediate Execution by whipping of the said Betty Game at the publick whipping
post with ten Lashes well laid on while the blood appears, and afterwards in the same Court
said Sher. and made return that he had done the Execution of the Judgment aforesaid as to the Corporal pun-
ishment aforesaid he was Commanded. Thereupon the said ^{Betty Game} is ordered to give Security for the payment
of the severall Officers their fees due upon the Information aforesaid, whereupon a certain Stephen Winn
right of Somerset County Bailayer present heron Court undertook for the said Betty Game to pay
severall Officers fees due as aforesaid &c.
