Therefore Judgment rendered that the Verdict aforesaid given be hold for nothing, and that the aforesaid Tucker Loyd of that same Verdict goe thro of without day he; whereupon the said Thomas Bluet who for his said Lordship in that part follows ^{prays} he; a new Tryal in the premises afo and to him it is granted. - Whereupon came into Court Levi Gale Esq; Clerk of the Indictments for Somerset County, and saith that he will no further prosecute against the afo Tucker Loyd of the felony afo he. Therefore the afo Tucker Loyd as to the felony be quiet and go thereof without day he. ---
