 Long Executor of the Last Will and testament of Jeffrey Long Dec: Unless the Said  
 Nathaniel Forke, James Peirce, John Wood Adm: of the Said Hugh Arbuthnot  
 Dec: by themselves or their Attorneys shall appear and answer unto <sup>the said</sup> Sam: Long  
 in a plea of Trespass upon the Case according to Law and that <sup>by</sup> good <sup>and</sup> Lawfull men of  
 your Bailiwick you make known unto the Person or Persons in whose hands you  
 make the Same Attachment and that he She or they be and appear before our  
 Justices of our County Court to be held as aforesaid to shew Cause if any he She or they  
 have why the Same goods Chattells Rights or Credits so attached in his her or their  
 hands ought not to be condemned and Execution thereof had and made according  
 to Act of Assembly in such Case made and provided if to him her or them it shall  
 seem meet and how you shall Execute this writt that you make unto our said  
 Justices at the Day and place aforesaid and have you then and there this Writt Witness

 known unto the said William Thompson that he be and appear at the time and place therein contained to

 of the aforesaid Nathaniel Forke, James Peirce, and John Wood, Adm: of the aforesaid  
 Hugh Arbuthnot Dec: by Levin Galt his Attorney, Coms and Says that he  
 cannot Garnay but that the Said W<sup>m</sup> Thompson (as Attorney in fact of the aforesaid  
 Andrew Thompson) has of the Rights and Credits of the said Nathaniel Forke,  
 James Peirce, and John Wood Adm: <sup>as</sup> to the Value of Six pounds three Shill-
