At William Horsey ----- Somerset County p. William Wye Dmd. Late of Somerset County Manner was attached to answer unto William Horsey of the part upon the case the 14th 1733 William Wye Dmd. And whereupon the said William Horsey by Francis Allen his attorney Complainant

That whereas the said William Wye the thirteenth day of December and Dmd. Seventeen hundred and thirty One at Somerset County aforesaid within the Jurisdiction of this Court was indebted unto the said William Horsey in three pounds Seven Shillings Current Money of Maryland and Six hundred and five pounds of tobacco for sundry properly chargeable in Account as by Account hereto annexed may in Court appear and being so thereof indebted the said Wm Wye in Consideration thereof the Day and Year aforesaid at the County aforesaid with in the Jurisdiction of upon himself did assume and to the said Wm Horsey then and there did faithfully promise that he the said Wm Wye the aforesaid three pounds Seven Shillings and Six hundred and five pounds of Tobacco to the said Wm Horsey when he should be thereunto Requested he would well and faithfully pay and Content ~~and Content~~ and altho the said Wm Wye five hundred and nine pence and one hundred and five pounds of tobacco Residue of the said three pounds Seven Shillings and Six hundred and five pounds of tobacco to the said Wm Horsey he hath paid and Satisfied Yett as to three pounds five Shilling and nine pence and one hundred and five pounds of tobacco the said Wm Wye his promise and Assumption aforesaid in some aforesaid made nothing Regarding but plotting and fraudulently Intending the said Wm Horsey in that of the Craftily and Subtily to Deceive and Defraud the said three pounds Five Shillings and nine pence and one hundred and five pounds of tobacco to the said Wm Horsey altho the same to Doe the said Wm Wye by the said Wm Horsey on the aforesaid thirteenth Day of December in the Year aforesaid and often afterwards at Somerset County aforesaid within the Jurisdiction aforesaid he was thereunto Requested hath not paid or Contented but the same to him either to pay or Content hath ~~Refused~~ ~~and still~~ Both Refuse and deny Whereupon the said Wm Horsey saith he is worse and hath Damages to the Value of Eight pounds Current Money of Maryland aforesaid and thereupon he brings Suit -----
