Thereupon the proceeding aforesaid between the parties aforesaid in the plea aforesaid is continued until the next Court and the same day is given to the aforesaid parties how also &c. —

All which said next Court to witt the twenty first day of November and Dow. One thousand seven hundred and thirty two came againe as well the aforesaid William Horsey as the aforesaid William Wye by their attorneys ap. and thereupon the said William Wye by his attorney aforesaid as before defends the force and injury when he says that he cannot gainway the action aforesaid of the aforesaid William Horsey, nor can he say but that he did abuse upon himselfe in manner and form as the aforesaid William Horsey above against him hath complained, and as to the damage of the same William Horsey by him by occasion of the premises in that part sustained the same William Wye saith and confesseth that the aforesaid William Horsey hath sustained damages by occasion of the premises further than his costs and charges by him about his suit in that part appoynted to three pounds five shillings and nine pence current money, and one hundred and five pounds of tobacco and not more and because the aforesaid William Horsey denyes not this but the same allegation to be true, prays Judge and those damages above confessed together with those costs and charges aforesaid to him adjudged be —

Therefore by consent of the parties aforesaid it is considered that the aforesaid William Horsey recover against the aforesaid William Wye Dow. his damages aforesaid to the witt three pounds five shillings and nine pence current money and one hundred and five pounds of tobacco by the same William Wye in force and confessed as also four hundred & fifty nine pounds of tobacco for his costs and charges aforesaid to the same William Horsey at his request by the Court here and consent of the parties aforesaid adjudged and the witt defined thereby

Thomas Bluett

Command was given to the Sher. of Somerset County that he should take John Crawford late of Somerset County Taylor if he should be found in his bailiwick and him should safe keep so that he might have his body before the Justice of his Lordships County Court of Somerset to be held at Widning Beck the third Tuesday of November ^{then} next to answer unto Thomas Bluett of a plea of trespass upon the case and that thereof he should not fail &c. —

At which said third Tuesday of November to witt the twenty first day of the same month and Dow. One thousand seven hundred and thirty two being the day of the return of the said writt came the said Thomas Bluett in his proper person and the Sher. of Somerset County to whom the foregoing writt was directed ^{likewise} came and made return therof to the Court here endorsed *Vir Regi Corpus et Animum* whereupon the said John Crawford by Francis Allen his attorney comes and defends the force and injury when he and the aforesaid Thomas Bluett then and there his writt aforesaid against the aforesaid John Crawford did not prosecute with effect but voluntarily permitted his suit to be discontinued —

Therefore ~~thereupon~~ afterwards to witt, at the same day and place, by direction of the Justice aforesaid were adjudged the same John Crawford
