Theophilus Dennis .. trespass upon the Case &c - And Whereupon the said Lazarus by Francis Allen his Attorney complains that whereas the said Theophilus the first Day of March ann: Dom: Seventeen hundred and thirty one at Somerset County aforesd Within the Jurisdiction of this Court was Indebted unto the said Lazarus in one Cow not under four Years old, not above Seven Years and ten Bushells of Indian Come as by Account here unto Amended may in Court appear and being so thereof Indebted the said Theophilus in Consideration thereof the Day and Year aforesd at the County aforesd Within the Jurisdiction aforesd upon himselfe did Assume and to the said Lazarus then and there did faithfully promise that he the said Theophilus the aforesd Cow and ten bushells of Indian Come to the said Lazarus when he should be there unto Requested he would well and faithfully pay and Content Nevertheless the said Theophilus his Promise and Assumption aforesd in forme aforesd made Nothing Regarding but Plotting and fraudulently Intending the said Lazarus in that parte Craftily and Subtily to Deceive and Defraud the said Cow and ten bushells of Indian Come the said Lazarus altho the same to do the said Theophilus by the said Lazarus on the aforesd first Day of March in the Year aforesd and often Afterwards at the County aforesd Within the Jurisdiction aforesd he was thereunto Requested hath not paid or to him for the Same in any Sort Contented but the same to him hitherto to Day or in any Sort for the same to Content hath Refused and Still Doth Refuse and Deny Where upon he saith he is worse and hath Damagd to the Value of five pounds - Current Money of Maryland and thereupon he brings Suit &c -
