

Where upon the said Theophilus Dennis in his own proper person appears and there upon the said Theophilus Dennis at the prayer of the aforesaid Lazarus Maddox by his attorney aforesaid is adjudged to give Speciall bail to the action aforesaid, Where upon a certain Samuel Stevens and Solomon Dennis of Somerset County planters present here in Court in their proper persons ~~undertakes~~ ^{the said} Theophilus Dennis ~~to answer for the said Lazarus Maddox~~ that if in case the said Lazarus Maddox shall recover Judgment in the plea aforesaid against the said Theophilus Dennis or that the said Theophilus shall be therein convict that then he the said Theophilus shall pay the Condemnation of the Court there upon or tender his body to the custody of the Just. of Somerset County in satisfaction thereof, or that they the said Samuel Stevens and Solomon Dennis will do the same for them. — There upon the said Theophilus in his own proper person comes and defends the force and injury when he and says that he cannot deny the action aforesaid of the aforesaid Lazarus, nor but that he did assume upon him self in manner and form as the aforesaid Lazarus above against him hath complained and as to the damage of the same Lazarus by him by occasion of the premises in that part sustained, the same Theophilus says and confesseth that the aforesaid Lazarus had sustained damages by occasion of the premises further than his costs and charges by him about his suit in that part apposed to one Cow of the age aforesaid and ten bushels of Indian Corn and not more and because the aforesaid ^{Lazarus} deny's not this but the same allegation confesseth to be true, prays Judgment and those damages above confessed together with his costs and charges aforesaid to him adjudged be: —

Therefore by consent of the parties aforesaid it is considered that the aforesaid Lazarus Maddox Recover against the aforesaid Theophilus Dennis his damages aforesaid to the aforesaid Cow of the age aforesaid and ten bushels of Indian Corn by the same Theophilus in form aforesaid confessed as also Two hundred and thirty nine ^{pounds} of Tobacco for his costs and charges aforesaid to the same Lazarus at his request by the Court here and consent of the parties aforesaid adjudged and the aforesaid defendant in werry ~~be~~

John Britt } Command was given to the Sher. of Somerset County that he should take John Magan
 John Magan - } late of Somerset County Schoolmaster otherwise called John Magan if he should be found
 in his Bailiwick and him should safe keep so that he might have his body before the
 Justices of his Lordships County Court of Somerset to be hold at dividing Beck the third wedday of
 November then next to satisfie John Britt as well of a certain debt of seven hundred pounds of tobacco
 which the same John Britt by his Lordships County Court of Somerset at dividing Beck the
 recovered against him as of two hundred and seventy seven pounds of tobacco which to the same John
 Britt in the same Court were adjudged for his damages which he had by occasion of the detaining of
