that he might have his body before this Lordships Justices of the County Court of Somerset to be held at Bridgwater the third Tuesday of November then next to satisfy Joshua Caldwell of his twelve hundred and thirty nine pounds of tobacco which to the same Joshua by the Justices of this said Lordships County Court of Somerset were adjudged for his costs and charges according to the form of the Statute in such case made and provided against parties plaintiff which then will do not prosecute or in the same should be precluded ther of the same Benjamin is committed att which said third Tuesday of November to witt the twenty first day of the same month and Anno One thousand seven hundred and thirty two came the said Joshua Caldwell in his proper person and the Coroners of Somerset County to whom the foregoing writ was directed Likewise came and made return thereof to the Court here endorsed in these words vid *Capi Corpus of Benj Holland*

Whereupon the said Benjamin Holland present here in Court at the prayer of the aforesaid Joshua Caldwell is committed by the Court into the custody of the Coroners aforesaid there to remaine until the said Joshua Caldwell of his aforesaid twelve hundred and thirty nine pounds of tobacco aforesaid should be fully satisfied the said Coroner to witt William Lane Gent present here in Court took charge of the said Benj Holland accordingly.

Ordered by the Court that William Hersey pay unto Daniel Long Junr Sixty pounds of tobacco being due unto him for his attendance two days as an Evidence on behalf of the said William Hersey against William Wye Junr the summe made oath to the same her —

Ordered by the Court that Dunker Lode pay unto William Wharton and Joshua Duke One hundred and twenty pounds of tobacco each for their attendance four days each as Evidence on behalf of his Lordships against the said Dunker Lode having made oath to the same her —
