Therefore it is considered by the Court here that the aforesaid Hope Adams pay unto his Lordship the Lord Proprietary for his fine by the Court here upon him imposed by reason of the premises aforesaid whereof in form afo he is guilty thirty Shillings and that the same Hope Adams be taken to satisfy the said Lord Proprietary of the fine aforesaid - Whorogon it is ordered by the Court here that the afo Hope Adams give Security to pay the fine afo and the Officers their fees due by reason of the premises afo, Whorogon aforesaid shall present before Court undertakes for the said Hope Adams to pay the fine aforesaid & the Officers their fees due by reason of the premises afo.

It is further ordered by the Court here that the afo Hope Adams give Good Security to save and keep Whorogon Somerset County for the time being from all sorts Charges and troubles whatsoever for a by reason of the birth maintenance nourishment and bringing up of the afo Bastard Child begot of the afo Sarah Hull alias Davis the - Whorogon the said Hope Adams with Philip Adams his Security both present here in Court acknowledged themselves to save and stand indebted unto his Lordship the Right honorable the Lord Proprietary in ten pounds Sterling each of their Goods and Chattels Lands or tenements Separately to be made and levied for the use of Somerset County if default be made in the condition here under written.

The Condition of the above Recognizance is such that if the above named Hope Adams his heirs Executors or administrators or any of them do and shall from time to time and at all times hereafter acquit discharge & save harmless the Justices of Somerset County & their Successors for the time being as also the Inhabitants of the said County from all sorts Charges and troubles whatsoever for a by reason of the birth maintenance nourishment and bringing up of the afo Child & of afo from all other sorts Charges & demands whatsoever touching or concerning the same then the above obligation to be void otherwise the
