Thereupon Command was given to the Sher: of Somerset County that he should take the said John Glas if &c. to answer &c. and afterwards here at this Court holden at Dwight Creek in Somerset County aforesaid the twentieth day of March and Dowd One thousand Seven hundred and thirty two before the Justices of the Same Court Judicially sitting came the aforesaid John Glas in his pro: per person according to a certain Recognizance by him and his pledges in that part before acknowledged and being Justantly demanded how he would acquitt himselfe of the trespass and assault aforesaid above upon him imposed, says that of the trespass and assault aforesaid as by the Judgment ~~in~~ aforesaid above upon him imposed he is Gilty thereof and is willing to pay his fine for the same wherupon all and Singular the premises by the Court has been read and fully understood & mature deliberation thereupon had &c.

It is Considered by the Court how that the said John Glas pay unto his Lordship the Lord pro: prietary for his fine here upon him imposed by reason of the trespass and assault aforesaid whereof in form aforesaid he is bound two hundred pounds of Tobacco and that the said John Glas be taken to satisfy his said Lordship of the fine aforesaid wherupon the said John Glas is bound to give Security for the payment of the same severall Officers fees due by reason of the premises aforesaid there: upon a certain John Pembrough of Somerset County present before this Court undertakes for the said John Glas to pay the severall Officers fees due as aforesaid &c.
