Therupon the same Anthony West, with Rendall Revele Late of Somerset County planter  
his Surety present heron in Court in their proper persons acknowledge themselves to owe unto his Lordship  
the Right Honorable the Lord Proprietary of the Province of Maryland £. iii. the Sum of fifty pounds  
Sterling each good and Lawfull money of England of their Several goods and Chattell Lands and tenements  
to the use of his said Lordship his heirs and Successors to be made and Levied. If it happen that the  
said Anthony West do not make his personall appearance before his Lordship Justice of the Next  
assize (viz. prim. Oyer and Terminer and Gaol delivery) to be hold at Dwidung Creek in Somerset County  
the first Tuesday of Aprile next to answer unto his Lordship of and Concerning the perjury aforesaid  
and do not stand and abide the Judgment of the Court thereon, and do not depart the same Court without  
Leave thereof, and do not in the mean time be of the good behaviour towards his said Lordship  
and all other his good people, then the above Recognizance to be in full force and virtue otherwise her.

ship his heirs and Successors. If it happen that the aforesaid Sarah Staples do not make her personall  
appearance before the Justice of the said Lordship's County Court of Somerset to be hold at Dwidung Creek the  
third Tuesday of June next, and do not answer unto his said Lordship of and Concerning her Committing of  
fornication, and having born of her body a bastard Child; and do not stand and abide the Judgment of  
the Court thereon, and do not depart the same Court without Leave thereof, then the above Recognizance  
to be in full force and virtue her.
