Command was given to the Just. of Somerset County that he should take Patrick  
Connelly late of Somerset County fellymaker otherwise called Patrick Conolly of the  
same place Hatter if he should be found in his bailey wick and him should safe  
Keep so that he might have his body before the Justices of his Lordships County  
Court of Somerset to be hold at dividing week the third Tuesday of March then next to answer unto John  
Tunstall Esquire of Hugh Porter according to act of Parliament in such case provided of a plea that he render  
unto him Sixty pounds Sterling which to him he oweth and he justly detaineth &c. and that there of he should  
not fail &c.

At which said third Tuesday of March to witt the twenty first day of the Same month and Dow.  
One thousand Seven hundred and thirty one being the day of the Return of the said writ Cometh the said John  
Tunstall by Lewis Gale his attorney and the Just. of Somerset County to whom the foregoing writ was direc-  
ted Likewise Cometh and maketh return thereof to the Court here Endorsed in these words viz. Epi Regis  
Jos. Baldwin Just.

Whereupon the said Patrick Connelly being <sup>called</sup> appears, and there upon the said  
Patrick Connelly at the prayer of the aforesaid John Tunstall by his attorney aforesaid is adjudged to give  
Special bail to the action aforesaid <sup>in the plea afo</sup> there upon a certain Thomas Fletcher of Somerset County Gentleman present  
here in <sup>his proper person</sup> Court undertakes for the said Patrick Connelly that in case the said John Tunstall should recover Judgment  
in the plea aforesaid against the said Patrick Connelly, or that the said Patrick Connelly should be therein Con-  
victed that then he the said Patrick Connelly should pay the Condemnation of the Court there upon or tender his body  
to the custody of the Just. of Somerset County in Satisfaction thereof or that he the said Thomas Fletcher will  
do the Same for him &c.

Where upon the said Patrick Connelly by William Beckingham his attorney  
comes and defends the force and Injury when &c. and prays Leave thereof to Impeale here until next  
court and he hath it and the Same day is given to the said John here also &c.

At which said next Court to witt the twentieth day of June and Dow. One thousand Seven hundred &  
thirty two came againe as well the said John Tunstall as the said Patrick Connelly by their attorneys afo and  
there upon the said Patrick prays further Leave thereof to Impeale here until next Court and he hath  
it and the Same day is given to the aforesaid John here also &c.

At which said next Court to witt the fifteenth day of August and Dow. One thousand seven hund-  
red and thirty two came againe as well the said John Tunstall as the said Patrick Connelly by their atty  
afo
