had born of her body a bastard child against the peace of the Right honble the Lord Proprietary of this  
Province his good rule and government and also against the form of the act of assembly in such case made  
and provided whereof the said Robert Jenkins Henry prays advisement of the Court in the premises and  
that due process of Law wherein against the said Catherine may issue the

Thereupon command is given to the Sher. of Somerset County that he should take the said Cat  
Dogan if she be answerable and afterwards in the same Court came the said Catherine Dogan in her  
proper person and had clearing of the Information aforesaid, and thereupon the said Catherine Dogan  
is instantly demanded how she would acquit herself of the premises aforesaid above upon her answer  
said, say that of the premises aforesaid above upon her Imposed she is guilty thereof but hath nothing to  
pay for fine for the fault aforesaid. Wherefore it is considered by the Justies here that the aforesaid  
Catherine Dogan be whipt at the publick whipping post with twenty five lashes on the bare back well  
laid on while the blood appear. Thereupon command is given to the Sher. of Somerset County that he  
should do therof immediate Execution by whipping of the said Catherine Dogan at the publick whip-  
ping post with twenty five lashes on the bare back well laid on while the blood appear and  
afterwards in the same Court came the said Sher. and made return that he had done the execution of the  
Judgment aforesaid as to the corporal punishment aforesaid he was commanded by. —

Twenty One years, the said Toby Dogan to serve his said Master his heirs or assignees

In consideration whereof the said Samuel Handy undertakes for to find and provide for his said  
Servant meat drink washing Lodging and Clothing sufficient for his said Servant to have and  
wear during the term aforesaid her. —

Ordered by the Court that William Bonham a poor Object be allowed four hundred pounds of tobacco towards  
his support and maintenance until November last next to be paid next Levy Court Day
