 Whereupon the said James Jones with John Caldwell of Somerset County Gentleman his Secur-
 ity both present here in Court acknowledged themselves to be Indebted unto the Said Mary Bashaw
 in the sum of twenty five pounds Sterling each of their bodyn Goods and Cattells Lands and ten-
 ements severally to be made and Levied to the use of the Said Mary Bashaw - if it happen
 that the aforesaid James Jones do not comply with the Law in Relation to the Gardian ship
 aforesaid, and do not deliver up all the Estate of the Said Mary Bashaw both Real and per-
 sonal, peaceably and quietly, when lawfully required &c.
