Whereas the same Moses Chapman was bound out by the Court an apprentice unto Abraham Humphrey Chapman, and forasmuch as the same apprentice did appear to the Court to be dullely and not able to learn the trade of a plasterer the which he was formerly bound to, and Likewise the said Humphrey Chapman master of the said apprentice present here in Court is willing that the said apprentice should be discharged from his service and bound out to some other service which is granted him by

Thereupon the said Moses Chapman present here in Court in his proper person is by the same Court of his own consent bound ~~by the Court~~ unto Abraham Rowland Hodge until he arrives at the age of Twenty one year the said Moses Chapman to serve his said master the full term of time aforesaid during which term the said apprentice his said master well and faithfully shall serve his servants keep his Commandments Lawfully and honestly every where willingly shall do and in all things as a good and faithfull servant shall demean himself towards his said master and all his during the term aforesaid &c.

In consideration of which service the said Rowland Hodge present here in Court in his proper person Covenanteth with the Justices of the same Court, in Court judicially sitting on behalfe of the said Moses Chapman that he the said Rowland Hodge during the term aforesaid will learn his said apprentice the trade of a weaver and at the Expiration of his service give his said apprentice anew suit of Cloathes over and above his Common wearing Cloathes, and Likewise provide for his said apprentice meat drink washing Lodging and Bathing and all other necessarys sufficient for such an apprentice to have and wear during the term aforesaid &c.

Whereupon It is Ordered by the Court here that the said Rowland Hodge give Recognizance with one Surety for to Comply with the Covenants aforesaid.

Thereupon the said Rowland Hodge with Charles Veasey of Somerset County planter his security both present here in Court in their proper persons acknowledged themselves to be indebted unto the said Moses Chapman in the Sum of twenty pounds Sterling of their body's goods or Chattells Lands or tenements Joyntly and Severally to be made and Levied to the use of the said Moses Chapman his heirs or assigns. If it happen that the said Rowland Hodge do not during the term of service aforesaid learn his said apprentice the trade of a weaver and at the Expiration of his service do not give his said apprentice anew suit of Cloathes over and above his Common wearing Cloathes and do not Likewise provide for his said apprentice meat drink washing Lodging and Bathing and all other necessarys sufficient for such an apprentice to have and wear during the term aforesaid &c.

At the prayer of the said Rowland Hodge the same Moses Chapman is discharged from paying of Taxes this present year &c.
