 plantation at the seaside is very prejudicial to me as it now stands which goes as it now is thro' my  
 plantation which as I am lately come thro' to Sea is very prejudicial therefore I humbly pray your worships  
 would be pleased to suffer me to bear a road as it formerly used to go which will not be above one hundred  
 yards further than what it now is and your petitioner as in duty bound shall ever pray.

The petition aforesaid being read and heard and fully understood and mature deliberation thereupon  
 had wherefore it is considered that the said John Teague turn the Road as by the petition afo is granted.

John White } John White son of Stephen White late of Somerset County decd. is by the Court of his  
 bound to } own consent bound unto John White Senr. until he arrives at the age of Twenty One.  
 John White } years the said John White the younger being sixteen years of age the fifth day of November  
 next the said John White the younger to serve his said Master John White the Elder the full term afo  
 said which term the said John White his said Master well and faithfully shall serve his secrets keep his  
 commands Lawfully and honestly every where willingly shall do and in all things as a good and faith-  
 ful servant shall demean himselfe towards his said Master and all his during the term aforesaid. In  
 consideration of which Service the said John White the Elder present here in Court in his proper  
 person covenanteth with the Justices of the Same Court in Court Judicially sitting on behalf of the said John  
 White the younger that he the said John White the Elder during the term afo will Learn his said apprentice the  
 trade of atle Copper and to read well in the bible and to write and cypher as far as the rule of three  
 Inclusive and at the Expiration of his Servitude give his said apprentice anew Suit of Cloathes over &  
 above his Common wearing Cloathes, and Likewise provide for his said apprentice meat drink washing  
 Lodging and Cloathing and all other necessary sufficient for such an apprentice to have and wear during  
 the term afo - Whereupon it is Ordered by the Court here that the said ~~John White the Elder~~ John White the Elder  
 give recognizance with one Surety for to comply with the covenants afo.

Whereupon the said John White the Elder with Randal Long of Somerset County planter  
 his Surety both present here in Court in their proper persons acknowledged themselves indebted unto  
 the said John White the younger in the sum of twenty pounds <sup>sterling</sup> of their body goods or Chattels Land  
 or tenements severally to be made and paid to the use of the said John White the younger his heirs or  
 assigns. If it happen that the said John White the Elder do not during the term of Servitude afo  
 Learn his said apprentice the trade of atle Copper and Read well in the bible and Write cypher  
 as far as the Rule of three Inclusive; and at the Expiration of his servitude do not give him anew Suit  
 of Cloathes over and above his Common wearing Cloathes, and do not Likewise provide for his said appren-  
 tice meat drink washing Lodging and Cloathing and all other necessary sufficient for such an apprentice to  
 have and wear during the term afo
