Be it Remembered that on the twentieth day of June anno Domini One thousand seven hundred and thirty three came here unto Court before His worshipfull William Fawcett and his associates Justices of the peace Robert Denhamis Henry Gent. who prosecute for the Lord Proprietor and giveth the Court to understand and be informed that Alestan Esther Bowe did Commit fornication and had born of her body a bastard Child on or about the tenth day of March and Dau One thousand seven hundred and thirty one in the County aforesaid within the Jurisdiction of this Court contrary to act of Assembly in such case and provided &c

Whereupon Command was given to the Jus. of Somerset County that he should take the said Esther Bowe if he to answer her and afterwards on the twenty first day of June and Dau One thousand Seven hundred and thirty three came here unto Court the said Esther Bowe in her proper person and had alsoing of the Information and being Justly demanded how she would acquit herself of premises and say that of the premises above upon her Imposse she is Guilty thereof and whereat Calk that Alestan Henry Gent is the begetter of the Child she stands informed against but hath nothing to pay her fine for the fault and her.

Wherefore it is Considered by the Justices here that the said Esther Bowe be whipped at the publick whipping post with fifteen Lashes on the bare back well laid on while the blood appear and that she be taken her and thereupon as to the Corporate punishment and Command is given to the Jus. of Somerset County that he do thenceforward make Execution by whipping of the said Esther Bowe at the publick whipping post with fifteen Lashes on the bare back well laid on while the blood appear and afterwards in the same Court the said Just. will make known to the said John Bowe all that he had done the Execution of the Judgment and as to the Corporate punishment as he was commanded her. Whereupon the said Esther Bowe is ordered to give Poly for the several Officers their fees due by reason of the premises and therupon Alestan Randal Long of Somerset County planter present before Court undertaken for to pay the several Officers their fees due as aforesaid her.
