One thousand Seven hundred & thirty three and had a hearing of the forewent, and being justly demanded how she would acquit herself of the premises, and upon her Impore, says that of the premises and above upon her Impore she is guilty thereof and puts herself upon the favour of the Court, and makes oath that Moses Chailes Ind. is the begetter of the Child she stands presented for but hath not wherewithal to pay her fine for the fact &c.

Wherefore it is Considered by the Justices here that the said Ann More be whipt with ten Lashes well laid on while the blood appear and that she be taken to the House of Correction as to the Corporal punishment and Command is given to the Just. of Somerset County that he do thereof immediately Execution by whiping of the said Ann More at the public whipping post with ten Lashes on the bare back well laid on while the blood appear and afterwards in the same Court came the same Just. to wit Joshua Caldwell Gent and made Return that he had done the Execution of the Judgment as to the Corporal Punishment and he was Comended; thereupon the said Ann More's Master to wit Christopher Glap present here in Court prays that the said Ann More may be adjudged to serve him after the Expiration of her Indented time ~~in~~ for the trouble, and Charge, and Loss of time, when the said Ann More Lay in, and for maintaining of her Child, and for tobans paid on acct. of the forewent prosecution which amounts in the whole, for trouble, loss, Charges, and Loss of time, and maintaining of the Child to be paid on acct. of the said prosecution ~~and~~ to Seven hundred and fifty five pounds of tobans ~~and~~ whereupon the said Ann More is adjudged to serve her said Master

Christo pher Glap after the Expiration of her Indented Servitude the full time of Eleven full months to Commence at the Expiration also, which Eleven month Servitude also is adjudged full Satisfaction for the said Seven hundred and fifty five pounds of tobans damages and paid as aforesaid and that the said Christo pher Glap pay unto the said Ann More all her freedom due, allowed by act of parliament. Whereupon it is ordered by the Court here that the aforesaid Ann More give security for her appearance at August Court next to give evidence against Moses Chailes Ind. on behalf of his Lordship &c.

Thereupon Christo pher Glap of Somerset County planter present here in Court in his proper person undertakes for the said Ann More and acknowledged himselfe to be indebted unto his Lordship the Right honorable the Lord Proprietary in five pounds Sterling good and Lawfull money of England of his body goods or Chattell Lands or tenement to the Use of his said Lordship his heirs and Assigns to be made and Levied -

If it Happen that the said Ann More do not make her personall appearance before the Justices of his said Lordships County Court of Somerset to be hold at dividing Week the third Wednesday of August then next, and do not give evidence on behalf of his said Lordship against Moses Chailes Ind. and do not depart the same Court without Leave thereof
