Therefore your worships petitioner prays your worships will be pleased to take it into your Consideration and Let your petitioner at Liberty and your petitioner as in duty bound will pray for — Am more —

Whereupon the afo Christopher Glast, and the said Am more being both present here in Court in their proper persons, the petition afo being Read and heard and all and Singular the promises as well on the part of the said Christopher Glast, as on the part of the afo petitioner, and also what James Martin of Somerset County Gent. delivered upon oath in relation to the said petitioners Indentures, and the Communication that past between the said Christopher Glast and the said More Chaile at the time of the Sale of the petitioner afo. all which being impartially weighed and duly consulted by and among the Justices of the same Court &c —

It is therefore Considered that the same Indenture by which the afo Christopher Glast held and detained the said Am more the petitioner as a servant is not good nor Sufficient in Law to hold or detain the said petitioner as a servant any longer and that the said petitioner be there of acquitt and go thereof without day &c

James an negro man (of the William Blanner) being ancient and Infirm is adjudged by the Court to be taxfree for the future &c

Att the prayer of Mr. James Martin of Somerset County Gent. he is discharged from paying of Taxes for his Negro woman Moll for being ancient and Infirm for the future &c

Matthew Bunnell } To the worshipful Justices of Somerset County Court your petitioner  
petl. . . humbly sheweth that he has an negro man which has been crippled by Loosing  
the use of one of his arms these three years past so that he has done him  
no service he finding no hopes of his doing any work for the future he being at great Charge by Employ-  
ing and order all to use Effect your petitioner prays your worships to acquitt him from paying any Levy  
for the said negro and your petitioner as in duty bound shall ever pray .. Matthew Bunnell —

The petition afo being Read and heard and fully understood and mature deliberation thereupon had therefore it is Considered by the Court here that the afo Matthew Bunnell be discharged from paying of Taxes for the afo Negro until he comes to the use of his arm again &c
