to. If it happen that the said Andrew Thompson do not make his personal appearance before the Justice  
of his said Lordships County Court of Somerset to be hold at dividing Creek the third munday of August next  
and do not answer unto his said Lordship of and concerning such matters and things as shall be then  
there objected against him on his said Lordships behalfe, and do not stand and abide the Judgment of the Court there-  
upon, and do not depart the Same Court without Leave thereof and is not in the meantime of the good be-  
haviour towards his said Lordship and all other his good people &c -
