in Manner here (to witt) the twenty first day of June one thousand seven hundred and thirty
three before his Lord^{ship} Justices of the Peace County Court of Soudth Now sitting at dividing brook -
Caused the aforesaid Elias Beavins in his proper person and had hearing of the Information
afo^r and say that he is not thereof Guilty and of this he puts himself upon the Country and Rob^t
Jonkins Henry Gent his Lordships Attorney in Court here, who in that part likewise followeth
Whereupon the same Elias Beavins Relinquisheth his Verification afo^r. by him above
alleged and say that he cannot gainsay but that he is Guilty of the Trespas and Assault
afo^r. in the Information afo^r specified, above upon him Imposed, in Manner and form as by
the Information afo^r above against him Supposed, and the Trespas and Assault afo^r in the
Information afo^r. Expressly Confesseth -

Upon this being seen and by the Court here Understood
all and singular the promises, it is Considered that the afo^r Elias Beavins pay to his said
Lordship the Lord prop^y. fifty pounds of Sol^d for his fine for and by occasion of the trespass and
assault afo^r in the Information afo^r. contained whereof he is Convict and that the said Elias
Beavins betaken to satisfy his said Lord^{ship} of the fine afo^r. the said Sher^{iff} to witt Joshua Caldwell
Gent^l present herein Court took Charge of the said Elias Beavins Accordingly afterwards
the said Elias Beavins is ordered by the Court here to give Security for the paymt of the severall
Officers fees due upon the Information afo^r. by Reason of the Promises afo^r. Thereupon
Mertan Rich^d Knight of Soudth County planter present herein Court undertakes for the said
Elias Beavins to pay the severall officers fees due upon the Information afo^r. for and by
Occation of the promises afo^r.

Proprietary in this part Prosecutes and gives the Court to Understand and be Informed that
Elias Beavins of Soudth County Planter the twentieth Day of June In the year of our Lord
one thousand seven hundred and thirty three at the County aforesaid and within the Jurisdiction
of this Court with force and Arms &c^t in and upon certain William Floman in the poace of
God and the said Lord prop^y. then and there being an Assault did make and him the said William
then and there did beat wound and evilly Intreat so that of Life it was greatly Disparred and
Other harms to him then and there did offer to his great Damage and against the poace of the
Right
