 clearly demonstrated by the worshipful Major William Blenner than is here prescribed, and also to prevent all  
 manner of danger that might ensue your humble petitioner doth oblige himself to clear and ditch an old Road  
 which shall be at convenient both to neighbours and passengers as the one now in use or may be thought fit by  
 Mr Thomas Dixon and Mr Thomas Williams or any other judicious neighbours sensible of the oppression of your  
 humble petitioner who is in duty bound to pray for the well fare and safe conduct of your worship.
