Thereupon Command was Given to the Sher. of Somerset County that he should take the said Patrick Connolly if he to answer &c and afterwards in the same Court came the said Patrick Connolly in his proper person and being by the Sher. set to the bar is thereupon Instantly demanded how he would acquit himself of the premises aforesaid, says that of the premises aforesaid he is Guilty of there of and is willing to pay his fine for the fact aforesaid &c

Therefore it is Considered that the aforesaid Patrick Connolly pay unto his said Lordship the right due to the Lord proprietary thirty Shillings for his fine by occasion of the premises upon him imposed and that the said Patrick Connolly betaken to Satisfie his said Lordship of his fine afo &c

Whereupon it is ordered by the Court here that the said Patrick Connolly Give Security Recognizance with One Security in the Sum of thirty pounds Sterling Cash to Save and keep aforesaid from time to time and at all times hereafter the Justices of Somerset County afo and their Successors for the time being as also the Inhabitants of the said County from all sorts Charges and troubles whatsoever for or by reason of the birth maintenance nourishment and bringing up of the Child aforesaid begott of the said Rachel &c

Thereupon the aforesaid Patrick Connolly with Hugh Porter of Somerset County Gent<sup>l</sup> his Security both present before Court in their proper persons acknowledged themselves to One & Stand Justly Indebted unto his said Lordship the Lord proprietary in the Sum of thirty pounds Sterling money each of their goods and Chattells Lands and Tenements Separately to be made and Levied for the use of Somerset County if default be made in the Condition hereunder written &c

The Condition of the above Recognizance is Such that if the above bounden Patrick Connolly do and shall from time to time and at all times hereafter acquit and discharge and Save himself as well the Justices of Somerset County afo and their Successors for the time being as also the Inhabitants of the said County from all sorts Charges and troubles whatsoever for or by Reason of the birth maintenance nourishment and bringing up the said Child and of and from all other Suits Charges troubles and Demands whatsoever touching or Concerning of the same then this obligation to be void and of none Effect otherwise &c
