Therefore it is Considered by the Court here, that the afo William Bilkard be quiet & Go thereof without
Day &c. whereupon it is ordered by the Court here that the afo William Bilkard Give Security for the payment of
the Several Officers their fees due by reason of the premises afo thereupon afo William Booth of the
county afo present here in Court undertakes for the Said William Bilkard for to pay the Several Officers their
fees due by reason of the premises in case the Said William Bilkard doth not pay the Same &c.

Thereupon the Said William Bilkard is ordered by the Court here that to give Recognizance in fifty
pounds Sterling, with two Sureties in twenty five pounds Sterling each for his Good behaviour and appearance
at June Court next &c.

Whereupon the Said William Bilkard with William Booth and Edward
Bust of Somerset County his Sureties all present here in Court in their proper persons and acknowledged themselves
to owe and stand Justly Indebted unto his Said Lordship the Said Proprietary in manner and form follow:
ing to wit - the afo William Bilkard in fifty pounds Sterling and the afo William Booth and Edward Bust
in twenty five pounds Sterling each of their Goods and Chattels Lands and tenements Separately to be made &
Levin, to the use of his Said Lordships his heirs &c. unless if default be made in the Condition hereunder written

The Condition of this Recognizance is Such that if the above bounden William Bilkard shall personally
appear at the next Court to be hold for Somerset County at dividing Creek the third Wednesday of June next, to do
and receive what shall be due and there Enjoyed by the Court, and in the meantime that he be of the Good
behaviour towards his Said Lordship and all other his people then the above Recognizance to be void and
of none Effect otherwise &c.
