Between them to award that Capt James Lindow pay unto the aforesaid John Stewart the sum of Eleven pounds One
Shilling and Eight pence Current money of Maryland which we do adjudge to be the balance due to said Plaintiff
as witness our hands. Thos Dashie, John Donaldson, James Martin & Isaac Fleming -

James Lindow the sum of Eleven pounds One Shilling and Eight pence Current money his damages and by the arbitrators
to be agreed as also Three hundred & Eighty eight pounds of tobacco for his costs
and charges to the same John Stewart by the Court hereof his agent adjudged and the aforesaid James Lindow
in mercy for
