Chambers and presentments against Bridget Smith, Ann Keaker, Mary Boniter, Foully Whittington and Rachel Wotton being Content that the Court should amend form altering noe matter of Substance in them and against the several persons so as at Indited and presented it is ordered that fugias issue Returnable here to next Court, whereupon the Grand Jurors as are discharged and ordered to be allowed five hundred pounds of tobacco (subjected to adduction) to be paid next Levy Court &c
