Wherupon the Said Thomas Duncan being called appears and wherupon the Said Thomas Duncan is ordered to give Security for the payment of the severall Officers their fees due by reason of the premises &c but for want thereof the Said Thomas Duncan is committed into the custody of the Sher. of Somerset County there to remain &c afterwards in the Same Court Case Albertani Joshua Hunger and Patrick Councilly of Somerset County and undertakes for the Said Thomas Duncan to pay the severall Officers their fees due by reason of the premises if the Said Thomas Duncan do not pay the Same &c wherupon the Said Thomas Duncan is discharged from the Commitment &c &c

Robert Ware -- } One of the Lord proprietarys Justices of the peace for Somerset County that Robert Ware late of Somerset County planter is Justly Indebted unto him the Sum of Eighty four pounds Six Shillings current money and fifteen hundred pounds of Tobacco and is Runaway and about to Remove his Effects out of this province You are hereby required Immediately to give attachment against the Effects of the Said Ware for the Said debt and all additional Costs and Charges that shall hereupon accrue anding to the form of the act of assembly in that Case made and provided howsoever fair not at your perille and for so doing this shall be your warrant Given under my hand and Seal the twenty Sixth day of June and One thousand Seven hundred and thirty One To Thomas Hayward of Somerset County
