All which said next Court to witt the twenty first day of August Ann<sup>d</sup> Dom<sup>d</sup>: One thousand Seven hundred and thirty three came againe as well the afo Adam Muir as the afo Walter Jacobs and Eliz<sup>o</sup> his wife by their attorney afo and whereupon the said Walter Jacobs and Eliz<sup>o</sup> his wife praye further Leave thereof to Imparke hereuntil next Court and they have it and the same day is given to the afo Adam here also &c

All which said next Court to witt the Twentysixth day of November Ann<sup>d</sup> Dom<sup>d</sup>: One thousand Seven hundred and thirty three came againe as well the afo Adam Muir as the afo Walter Jacobs and Eliz<sup>o</sup> his wife by their attorney afo and because the afo Adam Muir did not declare against the afo Walter Jacobs and Eliz<sup>o</sup> his wife in the plea afo nor did provent his writt afo against the same Walter and Eliz<sup>o</sup> &c

Therefore he and his pleges of proventing be in mercy and the ples name pleges &c and that the afo Walter Jacobs and Eliz<sup>o</sup> his wife admit of the afo Christopher Dashiell dec<sup>d</sup> go thereof without day also it is considered that the afo Walter Jacobs and Eliz<sup>o</sup> his wife recover against the afo Adam Muir his damages by occasion of the premises to Two hundred and seventy Seven pounds of tobacco to the same Walter and Eliz<sup>o</sup> by direction of the Justices here at their request for their costs and charges in that part sustained according to the form of the Statute thereof lately made and provided adjudged &c
