Fittue Rebecca Porter and Sarah Rice, Sarah Christopher Eliz. Harman and Lydia Schofield so as afo Indited it is ordered that capias issue against them Returnable to next Court &c

John McClester of Somerset County Esq. being appointed in his Lordship's Commission of the peace for the County afo, being present here in Court in his proper person took the several oaths appointed by act of assembly to be taken to the Government with the oath of Justice and Subscribed the oath of Abjuration and made and Subscribed the test, and took his place on the bench as above.
