I do here by Certifie that Woney McGammer was Qualifed as Constable of Manoran hundred by taking of  
the severall Oaths appoynted by act of assembly and signing the Bath of Abjuration & Making and Subscribing  
the last on the twelfth day of December anno Dni 1733. before Henry Balland -

His Lordship: } Somerset County f<sup>t</sup> The Jurors for the Right honble the Lord Proprietor that now is for  
body of Somerset County upon their oaths do present that Mary Maguire late of Slaney parish  
Mary Maguire in the County and the Servant of John McGester the second day of November in the Year of our

Lord God Seventeen hundred and Ninety three at the parish and in the County and within the Jurisdiction of this Court  
did committ fornication with certaine persons to the knowldge and unknown and did permitte the same unknown  
person ther and there to have carnall knowldge of her body and to begett them and there abisted Child on the  
body of her same men to the high displeasure of Almighty God to the Evill example of all others in such  
Cases offending Contrary to the peace of the said Lord Proprietor that now is his good rule and government and  
against the act of assembly in such case lately made and provided.

Teste mitholden while --- On the backside of the foregoing bill of Indictment it was thus endorsed viz.  
Billa vera Jn Burnall foreman.

Thereupon it was commanded the Sheriff of Somerset County that he shoud take the said Mary Maguire  
if she to answer and now hereafterward to witt the nineteenth day of March one thousand seven hundred and  
Ninety three before the Justices of his Lordships County Court of Somerset now held at Dwidig Creek in and for the  
County and came the aforesaid Mary Maguire in her proper person and being by the said set to the barre therupon  
instantly demanded how she would acquitt herselfe of the premises and above upon her Imposid sayd  
that of the premises and above upon her Imposid she is guilty thereof and makes with her a certaine John  
Hopkins Jrnd. is the begetter of the Child that she stands Indicted for but hath not where withal to pay her  
fine for the fact and her Wherfore it is considered by the Justices here that the aforesaid Mary Maguire be whipt  
with fifteen Lashes at the publick whiping post on the bare backe well laid on until the blood appear there-  
upon as the corporal punishment aforesaid is given to the Sheriff of Somerset County that he do thereof  
immediate Execution afterwards in the same Court came the said Sheriff and made returne that he had done the  
Execution of the Indictment and by whiping of the same Mary Maguire at the publick whiping post with fifteen  
Lashes on the bare backe well laid on until the blood did appear as aforesaid he was commanded.

Whereupon the said Mary Maguire is ordered to give security for her appearance before the Justices  
of his Lordships County Court of Somerset to be held at Dwidig Creek in the County and the third Tuesday of  
June next to give evidence on behalf of his Lordships against John Hopkins Jrnd. &c.

Thereupon John McGester of Somerset County gent present here in Court in his proper person  
undertakes for the said Mary Maguire and acknowledges himselfe to be Indebted unto his Lordships the  
Right Honble the Lord Proprietor in five pounds Sterling good and Lawfull money of England of his  
goods and chattell Land and tenement to the use of his said Lordships his heirs and successours to be made  
Levied If it happen that the said Mary Maguire do not appear before the Justices of his Lordships  
County Court of Somerset to be held at Dwidig Creek the third Tuesday of June next and do not  
then and thare give <sup>such</sup> evidence as he knows against the aforesaid John Hopkins Jrnd. or and Conser-
