that now is for the body of Somerset County upon their Oath do present that
Rachel Bratten late of Coventry parish in the County and spinner the first day
of December in the year of Our Lord God seventeen hundred and thirty three at the parish
and in the County and within the Jurisdiction of this Court did committ fornication with a certain Elias Taylor
and did permit the same Elias Taylor then and there to have carnal Knowledge of her body and to begat
then and there a bastard Child on the body of her the same Rachel Bratten to his high Displeasure of Almighty
God to the evill Example of all Others in such Case offending contrary to the peace of the said Lord Proprietary
by that now is his good Rule and government and against the form of the Act of Assembly in such Case Lately
made and provided &c. On the backside of the foregoing Bill of Judgment it was thus Endorsed by
Billa vera etiamne Wilton foreman.

Thereupon Command was given to the Sheriff of Somerset County that he should take the said
Rachel Bratten into his custody to answer her and afterwards to bring the Nineteenth day of March and Year One thousand
seven hundred and thirty three before the Juries of his Lordships the Lord Proprietary's County Court of
Somerset now held at Bridgwater in and for the County and Country the said Rachel Bratten according to
a certain Recognizance by her and her Security in that part first acknowledged in her proper person
and had a hearing of the Indictment and says that of the premises and above upon her Imposed
she is guilty thereof but hath not wherewithall to pay her fine for the said Act &c.

Whereupon all and Singular the premises by the Court here being seen heard and fully understood It is
considered that the said Rachel Bratten be whipt with three lashes on the bare Back at the publick whip-
ping post and that she be taken &c. Thereupon Command is given to the Sheriff of Somerset County that he
take the said Rachel Bratten to the publick whipping post and there give her three lashes on the bare back
and afterwards in the same Court bring the said Sheriff and make return that he had done the Execution of
the Judgment as to the corporate punishment and he was commanded &c.
