Billa vera Samuel Wilson foreman --- Thereupon Command was given to the Sheriff of Somerset County
that he shold take the said Elias Taylor if he to answer him and afterward to witt the nineteenth day of March
Anno Domini One thousand Seven hundred and Ninety three before the Justices of his Lordships the Lord Proprie.
Iary's County Court of Somerset now held at Widgwick Creek in and for the County aforesaid the said Elias
Taylor in his proper person according to a certain Recouerance by him and his Security in that part first
acknowledged and had a hearing of the Indictment agst him and say that of the premises and above upon him
Imposed he is guilty thereof and is willing to pay his fine for the fact aforesaid.

Whereupon and Singular the premises by the Court here being seen heard and fully understood
It is Considered that the said Elias Taylor pay to his Lordship the Lord Proprietary Six hundred pounds
of tobacco (to the use of Somerset County) for his fine for and by reason of the premises and whereof in form
and he is bound, and that the same Elias Taylor be taken to satisfy his said Lordship of the fine aforesaid.

Whereupon the said Elias Taylor is ordered to give security for the payment of the fine and the several Officers fees
Due by reason of the premises and thereupon a certain Thomas Prior present herein Court in his proper
person undertook for the said Elias Taylor for to pay the fine aforesaid and the several Officers fees due as aforesaid
Likewise the said Elias Taylor is ordered to give security for to save and keep himself as well the
Justices of Somerset County Court and their Successors for the same being as also the Inhabitants of the said
County from all Costs Charges and Troubles by reason of the birth maintenance nourishing and bringing up
of a Bastard Child lately begott by him the said Elias Taylor of a certain Rachel Bratton ye.

Whereupon the said Elias Taylor with Thomas Prior his security both present herein Court acknowledged
themselves to be indebted unto his Lordship the Lord Proprietary in the sum of Twenty pounds Sterling
good and Lawfull money of England of their severall goods and Cattell Lands and tenements to be made
and Levied to the use of Somerset County. If it happen that the said Elias Taylor do not from time
to time and at all times hereafter acquit discharge and Save himself as well the Justices of Somerset
County Court aforesaid and their Successors for the same being as also the Inhabitants of the same County or from all
Costs Charges and Troubles whatsoever for or by reason of the birth maintenance Nourishing and bringing
up the Child aforesaid and of and from all his charges and demands whatsoever touching or concerning of
the same etc

that Stephen Winwright late of Stepney Parish in the County aforesaid
the tenth Day of August in the year of Our Lord God Seventeen Hundred

Did Commit Fornication with a certain Elizabeth Townsend and of her body there and
there had carnal Knowledge and a bastard Child on the body of her the same Elizabeth
there and there did beget to the high displeasure of almighty god to the will Example of all
Others in such case offending contrary to the Peace of the said Lord Proprietary that now
is his good rule and government and against the Form of the Act of Assembly in such case
