

Court Did Commit Fornication with a certain Thomas Larrimore Junr. and Did permit the same Thomas Larrimore then and there to have carnal Knowledge of her body And to beget then and there a Bastard Child on the body of her the same Alice Hopkins to the High Displeasure of Almighty God to the Evil Example of all others in such Case offending Contrary to the Beedee of the said Lord Proprietary that now is his good Rule and Government and against the Form of the Act of Assembly in such Case lately made and provided &c.

On the behalf of the foregoing bill of Indictment it was Endorsed in these words, viz Billia Vera Sam Wilson foreman -- Thereupon Command was given to the Just. of Somerset County that he should take the said Alice Hopkins if she to answer and afterwards to wit the nineteenth day of March and Dow: One thousand Seven hundred and thirty three before the Justices of his Lordships the Lord Proprietarys County Court of Somerset now held at Dwiding Creek in and for the County and came the said Alice Hopkins in her proper person and being by the Sheriff Led to the Bar is Thereupon Instantly demanded how she would acquit herself of the premises and above upon her imposed say that of the premises and above upon her imposed she is guilty thereof and is willing to pay her fine for the fact and whereupon all and singular the premises by the Court here seen heard and fully understood. It is Considered by the Court that the said Alice Hopkins pay to his Lordships the Lord Proprietarys Two hundred pounds of Tobacco (for the use of Somerset County) for her fine for and by occasion of the premises and whereof in four parts she is Convict and that the same Alice Hopkins be taken to debt for his said Lordship of the fine and whereupon it is Ordered by the Court that the said Alice Hopkins give security for the payment of the fine and the several Officers their fees due by occasion of the premises and thereupon William Porter of Newwattins in Somerset County planter present herein Court in his proper person undertook for the said Alice Hopkins for to pay the fine and the several Officers fees due as aforesaid.

Likewise the said Alice Hopkins is Ordered to give Security for ^{her} appearance before the Justices of his Lordships County Court of Somerset to be hold at Dwiding Creek the third Tuesday of June next to give Evidence on behalf of his said Lordship against Thomas Larrimore Junr.

Whereupon the said Alice Hopkins with the said William Porter her Security both present herein Court in their proper persons and acknowledged themselves Indebted unto his Lordship the Lord Proprietary in the sum of ten pounds Sterling Cash, of good and Lawfull money of England of their several goods and Chattels Lands and tenements to be made and Levied to the use of his said Lordship his heirs and Successors If it Happen that the said Alice Hopkins do not make her personall appearance before the Justices of his Lordships County Court of Somerset to be hold at Dwiding Creek in the said County the third Tuesday of June next and do not then and there give Evidence as she knows against Tho: Larrimore Junr. of and Concerning his begetting of a bastard Child on the body of her the said Alice Hopkins and do depart thence without Leave of the Court &c.
