Now hereat this day to witt the nineteenth day of March and Dom one thousand seven hundred and thirty three before the Justices of his Lordships County Court of Somerset hold here at Dwiding Creek in and for the same County came the said John Evans under Custody of Joshua Caldwell Gent Sheriff of the County of Somerset to whose Custody before this time was committed for the cause aforesaid and by the said Sheriff being led to the Bar in his proper person whereupon the said John Evans is Instantly ordered by the Court to give security for his appearance before the Justices of the next assize Oyer and terminer and Goal deliver to be held for Somerset County at Dwiding Creek in and for the County the first Tuesday of April next &c. but for want thereof the said John Evans is committed into the Custody of the Sheriff of Somerset County there to remain untill delivered by due Course of Law &c. the said Sheriff to witt Joshua Caldwell Gent present herein Court in his proper person took Charge of the said John Evans accordingly &c

Thereupon the said John Jackaman present here in Court in his proper person acknowledged himself to be indebted unto his Lordship the Lord proprietary in five pounds Sterling Good and Lawfull money of England of his goods and Chattels Lands and Tenements to the use of his Lordship his heirs and Successors to be made and levied if it happen that the said John Jackaman do not make his personal appearance before his Lordships Justices of the next assize Oyer and terminer and Goal Deliver to be held at Dwiding Creek in and for the County the first day of April next &c do not then and there give such
