Whereupon the said Joseph Harden with John followers of Somerset County weaver by security both present here in their proper persons acknowledged themselves indebted unto his Lordship the Lord Proprietary in five pounds Sterling good and Lawfull money of England of their severall goods and Chattells Lands and tenements to be made and Lived to the use of his said Lordship his heirs and Successors if it happen that the said Joseph Harden do not make his personall appearance before the Justices of his Lordships County Court of Somerset to be held at Dodington Creek the third Tuesday of June next and do not answer unto his Lordship of and concerning what shall be objected against him on his said Lordships behalfe and do not stand and abide the judgment of the Court therepon and in the mean time if he be not of the good behaviour toward his said Lordship and all other his good people &c -

It is likewise further ordered by the Court here that the said Joseph Harden give security for the payment of the severall Officers fees due by reason of the premises and thereupon the said John followers undertakes for the said Joseph Harden to pay the severall Officers fees due as aforesaid -

Whereupon the said Eleanor Harden ab. Hardy came herein to Court before the Justice thereof the 11th Day of March One thousand Seven hundred and Thirty Three according to a certain Recognizance by her and her Security before acknowledged and prayd that she and her Security may be discharged therefrom whereupon the said Eleanor Harden and her Security are discharged &c. whereupon the said Eleanor Harden is ordered to give security for the payment of the severall Officers fees due as aforesaid thereupon after Benjamin Sharp of Somerset County Skipwright present here in Court undertaken to pay the severall Officers fees due as aforesaid

Nicholas Fountain appears according to his Recognizance entered into last Court for his good behaviour and appearance at this Court and accordingly discharged &c
