And whereupon the said John by George Douglas his attorney saith that whereas the said Bartholomew the tenth day of November One thousand seven hundred and thirty two at the County as within the Jurisdiction of this Court by his certain Writing Obligatory did acknowledge himself to be bound unto the said John in the said Six hundred and Eighty four pounds of tobacco to be paid unto the said John when he should be hereunto Required yett the said Bartholomew tho: often Required the said Six hundred and Eighty four pounds of Tobacco to the said John hath not Rendered but the same unto him hitherto to render hath denyed & still doth deny and unjustly detaineth whereupon the same John saith that he is worse & hath Damage to the Value of thirtie hundred & Sixty eight pounds of Tobacco & thereof he brings Suite & and brings hereinto Court the Writing as which the debt as in form as doth testify whose Date is the same Day & Year as doth. — Bledges & Le Doe & Pebrace

Whereupon the said Bartholomew Baynom present herein Court in his proper person at the prayer of the said John Ailworth by his attorney as is adjudged to give special Bail to the action as thereupon certain John Gornwell of Somerset County planter present herein Court in his proper person undertakes for the said Bartholomew Baynom that if in Case the said John Ailworth should recover Judgment in the plea as against the said Bartholomew Baynom or that the said Bartholomew shall be thornin Convict that then he the said Bartholomew shall pay the Condemnation of the Court thereupon or Render his body to the Custody of the Sher. of Somerset County in Satisfaction thereof or that he the said John Gornwell will do the same for him the

Whereupon the said Bartholomew Baynom in his own proper person comes and defends the force and Injury whereof and says that he cannot gainsay the action as of the said John Ailworth ~~whereof~~ ~~that~~ ~~he~~ ~~cannot~~ ~~gainsay~~ but that the writing Obligatory as is in deed nor but that he owes the same John Ailworth the said Six hundred and Eighty four pounds of tobacco in manner and form as the said John above against him hath declared wherefore the said John prays Judgment for his debt as and his Damages Sustained by Omission of the detaining of the same debt the.
