as the said William Turpin the first Day of April in the Year of Our Lord Seventeen<sup>hundred</sup> & thirty three at Somerset County afo was Indebted unto the same Joshua in the Sum of fourteen hundred and sixty pounds of Tobacco for the securing Imprisoning and Nourishing Honor Haley the Servant Woman of the same W<sup>m</sup> Turpin One hundred and sixteen Days at his special Instance & Request as by a particular Account thereof herewith into Court brought may appear and so thereof being Indebted the same W<sup>m</sup> Turpin the Day and Year afo at the County afo in Consideration thereof upon himself assumed and to the same Joshua then & there faithfully promised that <sup>he</sup> the same W<sup>m</sup> Turpin the same fourteen hundred & sixty pounds of Tobacco to the same Joshua when thereof afterwards he should be required well & truly would pay & Content Never the less the afo W<sup>m</sup> Turpin his promises Assumption afo nothing regarding but minding & fraudulently Intending the same Joshua in that part craftily & Subtly to Deceive & Defraud the same fourteen hundred & sixty pounds of Tobacco or any part thereof tho' often therewith particularly on the first Day of November in the year afo at the County afo requested to the same Joshua he hath not paid or him for the same in any Sort Contented but the same to him to pay or for the same in any Sort to Content altogether refused & still doth refuse to the Damage of the same Joshua three thousand pounds of Tobacco and thereof he brings Suit &c. — Bledges &c: He Doe & R. At which said third Tuesday of March to wit the nineteenth Day of the same month and Day One thousand Seven hundred & thirty three being the day of the Return of the same Writ Cometh the said Joshua Caldwell by his attorney afo and the Coroners of Somerset County to whom the foregoing writ was directed Likewise come and made return hereof in these words following vizt Capi Corpius declaration in time of W<sup>m</sup> Lane Coroner

Whereupon the said William Turpin by Francis Allen his attorney comes and defend<sup>t</sup>. the same and justify when &c. and saith that he did not assume upon himself in such manner and form as the afo Joshua above against him hath complained and of this he doth put himself upon the Country &c. and the plaintiffs in like manner.

Thereupon it is Comanded the Coroners of Somerset County that immediately they should come to Court here before the Justice of his Lordships County Court of Somerset now hold at Dividing Creek in & for the County afo Twelveth. by whom &c. and who neither &c. to be quire &c. because as well &c. and afterwards
