

A Copy of the foregoing Declaration was made and sent to be served on the Deft with the Writ in the plea and according to act of assembly in such case made and provided -

All which said third Tuesday of March to wit the nineteenth day of the same month and Dow. one thousand seven hundred and thirty three being the day of the return of the said Writ Cometh the said John Houston by his attorney and the Sher. of Somerset County to whom the foregoing writ was directed Likewise Cometh and makes the return thereof to the Court here Endorsed in these words following viz: Copy of Declaration in time of Joshua Caldwell Sher -

Whereupon the said Dennis Erdogan in his own proper person appears and thereupon the said Dennis Erdogan at the prayer of the said John Houston by his attorney and is adjudged to give Special bail to the action and but for want thereof the said Dennis Erdogan is committed into the custody of the Sheriff of Somerset County there to remain &c. The said Sheriff to wit Joshua Caldwell sent by John Dennis and his deputy present here in Court took charge of the said Dennis Erdogan accordingly &c -

Whereupon the said Dennis Erdogan in his own proper person comes and defends the force and Injury when &c. and saith that he cannot deny the action and of the said John Houston nor can he say but that the said John Houston ought to recover against him the said Eight hundred pounds of Tobacco by Breach of the breach of Covenants and together with his Costs and Charges sustained by Breach of the premises and wherefore the said John Houston prays Judgment for the said Eight hundred pounds of Tobacco in form and confessed as also his Costs and Charges to him be adjudged &c

Therefore by Consent of the parties and it is considered that the said John Houston Just Recover against the said Dennis Erdogan and Elizth his wife the said Eight hundred pounds of Tobacco in form and confessed as also Three hundred and Twenty three pounds of Tobacco for his Costs and Charges and to the same John by the Court has and Consent of the parties and adjudged &c the said Deft in mercy &c

His Lordship the right honorable the Lord Proprietary of the province of Maryland Commanded the Sheriff of Somerset County by his writ in these words following viz: Somerset s. Charles absolute Lord and Proprietary of the provinces of Maryland and Avalon Lord Baron of Baltimore &c. To the Sheriff of Somerset County greeting we Command you that you attach any the goods Chattels Rights or Credits of Samuel McCall John Blackburn John Allen Sate of Somerset County Maryland if they shall be found in your Bailiwick To the Value of Two pounds ten shillings & Six pence ^{Money} and five hundred pounds of Tobacco and when you have the same attached or any part thereof the same in your Custody safe keep so that you have the same before our Justices of our County Court of Somerset to be held at Dividing Creek the third Tuesday of March Next then and there to be condemned according to Act of Assembly to and (for
