Defends the force and Injury when *af* and says that the *af* John his Accon *af* there of  
against to have and maintain Ought not because he says that well and True it is that  
before the Speaking and publishing the words in the Declaration *af* above mentioned  
viz<sup>t</sup> on the first Day of April And Done Seventeen hundred and thirty at the County  
aforesaid within the Jurisdiction of this Court a certain Dispute and Difference happened  
between the *af* John and a certain Robert Given in a Matter of Account between the  
said Hooffington <sup>and said Given</sup> and the said Matter being Legally at Issue between the said Hooffington
