but that he did assume upon himself in manner and form as the said John above against him hath
Complained and as to the damage of the same John by him by Omission of the premises of the premises
in that part Sustained the same William saith and Confesseth that the said John has Sustained damages
by Omission of the premises beyond his Costs and Charges by him about his Suit in that part opposed
to four thousand nine hundred and Sixty nine pounds of tobacco and not more and because the said
John deny's not this but the same allegation Confesseth to be true prays Judg'd for those damages above
Confessed together with his Costs and Charges and to him to be adjudged he

Therefore by Consent of the parties and it is Considered that the said John Burnale Recover against
the said William Gray his damages and to four thousand nine hundred and Sixty nine pounds of tobacco
and Charges and to the same John by the Court here and Consent of the parties and adjudged and the
said William in mercy he

hundred and thirty One at Somerset County aforesaid and within the Jurisdiction of this Court was
debted to the said Adam in the sum of four pounds Current Money of Maryland for a Clerk by
the same Adam unto the aforesaid Robert Townsend at the special Request and Request of the
said Robert Townsend before that Time there sold and Delivered (as by an Account thereof here in
Court ready to be produced may appear) and so thereof Debted the said Robert Townsend in Considera-
ation thereof (to witt) the same Day and Year aforesaid and within the Jurisdiction aforesaid upon
himself did Assume and to the said Adam then and there faithfully did promise that when
afterward he should be thereunto requested the aforesaid sum of four pounds Current Money aforesaid
he
